 - Nextdoor app not encrypted and expected to sell data in future, as noted in recent media reports – Editor add note in News & Views
 - Co-ordinators set up WhatsApp or Signal group for Volunteers as encrypted programmes not selling data. Clerk INSTRUCTED to thank parishioner for offer to set up a Group
 - Parishioners over 70 or self-isolating for other reasons able to make phone calls but not deliveries
 - Clerk INSTRUCTED to: set up and maintain new webpage dedicated to response, information and advice, prominent link from website home page; contact Co-ordinators for Bodenham, Sutton and Moreton and provide Marden response details and contacts; check with insurers data required re Volunteers' activities
 - Clerk INSTRUCTED to: check with Mace Shop and European Shop if able to take orders and payment over phone from parishioners, for Volunteers to collect and deliver; ask Golden Cross if doing take away/meals on wheels
 - RESOLVED to pay reasonable administration costs of Co-ordinators, without further prior approval
 - Clerk INSTRUCTED to cancel: all PC meetings and activities in April; litter pick suggest litter picking if walking for exercise, equipment available from Vice Chair
 - Clerk INSTRUCTED to cancel: VE Day 75 event, NOTED may be rescheduled nationally with VJ Day in August; Marden Community Fete – when agreed with church and Fundraising Group Chair
 - Herefordshire's PC Summit and S&A Liaison Meeting cancelled
 - Community Centre closing for all meetings and groups, apart from Pre-school who providing key worker child care during partial closure
